BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision on the execution of the budgets adopted by the board and shall hold the department heads responsible for performance of their responsibilities within the amounts appropriated by the board of education and in keeping with the budgetary policy statement hitherto adopted by the board. Note: The General Education tax levy for 2021 is proposed to be 0.1434 mills and the Regional Enhancement tax levy for 2021 is proposed to be 1.4977 mills. These millages will be levied on all properties to be used for operating purposes as described above.
