2022-2023 CTE Barbering Program Guidelines

Overview

CTE Barbering prepares students with the knowledge required to take the State Board of Barbering examination and fulfill the licensing process. Within the Barbering curriculum, a student will gain marketable skills, business career awareness, and the key characteristics necessary to be successful in the ever-changing barbering industry.

Enrollment means you have made a commitment to attend an 1800-hour, State of Michigan, regulated occupational program. A student enrolling as a junior can complete most of this obligation by maintaining **excellent attendance** throughout their junior/senior year and attending full-time during the summer between. A student beginning enrollment as a senior has an opportunity to achieve a good portion of these hours as well.

CTE will cover the student tuition costs associated with enrollment, through the date of the student's high school graduation. The barbering curriculum is 300 more hours than cosmetology. There are not enough hours available for a student to complete the program. If a student has excellent attendance during the school year and attends class during local school days off including breaks, they should plan to pay for about 100 hours. If a student follows CTE's minimum hour expectations, they should expect to pay for approximately 300 hours. All hours not completed by graduation, are the student's responsibility.

During CTE enrollment, students will have access to community equipment (tools). Conversely, a student will need to purchase his/her own supply kit before sitting for their licensure exam. For this reason, students are encouraged to talk with the beauty school about how to purchase their own kit upon acceptance into the program. Owning one's own kit will enable a student to work much more independently during and outside the school day.

Barbering is held **12:30 p.m. – 4:30 p.m. Monday – Friday** during the school year. If you miss one day, makeup will require attending class on a day when your high school isn't in session.... Ask yourself, "How many days did I miss school during this past year?" "If I have the same number of absences while enrolled in Barbering, how will I make up the missed class time?"

Be sure you are ready to make this commitment!

Performance Hours and Grades

To receive a passing grade in Barbering, the student must successfully fulfill academic and skill expectations and meet a minimum cumulative performance hour requirement. 2022-2023 CTE Barbering **Program Guidelines**



Bring this packet with you to the orientation on May 11, 2022.

New enrollees in the Barbering program should be aware of the following program guidelines:

- 1. A junior student is committing to two-full years of coursework plus 240 hours during the summer between the student's junior and senior year.
- 2. A student beginning enrollment as a senior is committing to finishing the program, after high school graduation at their own expense.
- 3. CTE will pay all tuition costs incurred by the student through their high school graduation.
- Barbering is from 12:30 4:30 PM, Monday Friday, during the school year. Summer hours will vary.
- 5. Student academic & skill performance along with performance hours are reported at the end of each trimester/semester. If the student is failing in any of these areas, the student's progress will be reviewed by the beauty school and CTE to see if the student is eligible to continue with the program.
- 6. Credits for this experience are defined by the individual's school district.
- 7. Students are expected to dress according to the beauty school's rules.
- 8. The beauty school will provide students with information on how to purchase a supply kit.
- 9. Barbering attendance policies, except for summer hours, are the same as the local high schools.
- 10. Students are required to call if they will be late or absent from class. A note from the student's parent/guardian and/or school must be provided upon his/her return to class.
- 11. CTE students must follow beauty school and home district rules of conduct when in attendance.
- 12. Personal services are allowed. If the service is part of an assignment, there is no charge. If the service is elective, the student may bring in his/her own professional product for approval and usage at no charge or pay the beauty school for any chemicals used.
- 13. Questions about transportation to this program need to be directed to the student's home district. All students are responsible for transportation home.
